- Amplify the existing good; foster futuristic & possibility thinking; reframe problems into possibilities
- Emphasize and enable collective strengths & talent
- Create a climate of collective accomplishment.

Considering it is not easy to make people understand the importance of evaluation, let alone participate in such a process with transparency and involvement; she proposes a generative approach, called 'A-Valuation' ('Appreciative Evaluation') Unlike typical gap-analysis approaches, this process helps dissolve resistance and makes people come forward to participate willingly and creatively in the process of evaluation.
